  - 3) Would you be able to elaborate on your work as co-faculty in the Transgender Seminarian Leadership Cohort? How does this relate, if at all, to your aspiration to provide spiritual and pastoral care within queer and trans communities? (11:15-11:20)
  - 4) Based on previous communication that we have had with each other, you seemed to be very invested in Duke's National Coming Out Day. Would you be able to elaborate on that? How did you feel on that day? What did you find was most special to you about that day? (11:20-11:25)
