- 1. Hello Vaughn! How are you doing?
- 2. Are you ready for us to record the interview?

- 2) How is it like taking on the role of Co-President in this organization?
- Prompt #2: I see that a big part of Duke's Black Women's Union does is "celebrating the experiences of trans, queer, disabled, and low-income women" and "welcoming Black nonbinary or gender-nonconforming folks who feel drawn to our space while recognizing that their experiences are fundamentally different than those of Black women."
 - 3) Would you be able to elaborate on any experience and/or feelings you may have had with accommodating these various individuals throughout your time in the Black Women's Union?
- **Prompt #3:** Given everything that we have discussed so far...
 - 4) What has resonated with you the most regarding the Black Women's Union?
 - 5) What do you hope to do in the future in the Black Women's Union (whether that be anything different or similar to what you are already doing in the organization)?
- Part II: Life (I want to now transition into questions about your life in general)
 - **Prompt #1**: I am aware that you originally lived in Maywood, Illinois before you eventually came here to Durham, North Carolina.
 - 1) If you feel comfortable, would you be able to elaborate on what your childhood was like?
 - Prompt #2: I see that you were formerly a student of Fenwick High School, where you were named a LINK Unlimited Class of 2021 QuestBridge Match Scholar, and, from what I understand, it is very difficult to become a LINK Unlimited QuestBridge Match Scholar.
 - 2) Would you be able to elaborate on how you navigated the competitive process of becoming a LINK Unlimited QuestBridge Match Scholar and more on the emotions you felt once you had become one?
 - Prompt #3: I also know that, at your high school you were a Friars'
 Cheerleading Team captain and Black Student Union president.
 - 3) What did you find most special about these activities?
 - 4) How did these activities impact your advocacy work for Black women today?
 - Prompt #4: I am also aware that your high school was a Catholic college preparatory high school.

- 5) How did the fact that your high school education was influenced by Catholicism ultimately influence you as a person as well as your advocacy work (if at all)?
- Part III: Academic Career/Future Career Aspirations (Finally, I would like for us to transition into questions that relate to your academic career and future career aspirations)
 - **Prompt #1**: I have learned that you are currently an undergraduate senior at Duke University and that you are pursuing a Global Health major and African and African American Studies major.
 - 1) Would you be able to elaborate on why you chose to pursue these specific academic programs?
 - <u>Prompt #2</u>: I have also learned that you are currently an undergraduate researcher as a part of Duke University's Bass Connections program and that you were even a part of its Story+ program.
 - 2) Would you be able to walk me through what you found most significant about your Bass Connections and Story+ experience?
 - **Prompt #3**: Given everything that we have discussed regarding your life, academic career, and advocacy work...
 - 3) What do you hope to pursue as a career after college?
