  - <u>Prompt #1</u>: I am aware that you are Editor-in-Chief & Policy Director of *The Flow*, Duke University's first student-run publication that is dedicated

to covering the stories behind reproductive health through the lens of art, culture, writing, and academic research.

- 1) How is it like taking on the role of Editor-in-Chief and Policy Director for this publication?
- **Prompt #2:** In the "Team" page of *The Flow*'s website, I see that you have mentioned that "growing up, you did not always realize how important of a role reproductive health policy played in people's everyday lives.
  - 2) With that being said, what ultimately caused you to advocate for reproductive health outside of just your interests in community health and health equity? Why?
  - 3) How did the thing(s) that caused you to advocate for reproductive health relate to why you took on the role of Editor-in-Chief and Policy Director for *The Flow*?
- **Prompt #3:** Outside of your involvement with *The Flow*, I am aware that you wrote an article called "Closed for Business: The Current Trend of Southern Abortion Clinics" for *Ms. Magazine*, which relates to your current work as Reproductive Research Fellow for the Population Institute. In this article, you touch on the fact that, with recent abortion bans that have occurred in the South, the amount of physicians who choose to reside in this region of the United States has dropped. Because of this, you state that "if no one fills the growing vacuum left by physicians fleeing criminalization of abortion, reproductive health services will suffer more than they do now."
  - 4) Would you be able to elaborate on the ways in which reproductive health services are currently suffering outside of just the number of physicians that are available to staff them?
  - 5) Given your role as an advocate for reproductive health, what do you believe that everyone should do to bolster reproductive health services (aside from increasing the number of physicians that reside in the South)?
- 2. Part II: Life (I want to now transition into questions about your life in general)
  - **Prompt #1**: I am aware that you are originally from Cincinnati, Ohio before you eventually came here to Durham, North Carolina.
    - 1) If you feel comfortable, would you be able to elaborate on what your childhood was like?
  - Prompt #2: I am also aware that you were formerly a student of William Mason High School. I know that you graduated Summa Cum Laude from this institution as a National Merit Scholar Finalist, AP Scholar with Distinction, and with a student who obtained the Spanish Seal of Biliteracy. I also know that you engaged in various activities such as

Science National Honor Society, Spanish National Honor Society, Student Government, and Varsity High School and Club Swim Team.

- 2) On that note, what activities did you find were most special to you and why?
- 3) How did these activities impact your advocacy work for reproductive health if at all?
- Prompt #3: I have also learned that you have taken on many volunteering opportunities such as being Treasurer and English Tutor for GANO at Duke University, Bilingual Patient Resource Navigator for the Duke University Health System, an intern for Jillian Riley's campaign for Durham Soil and Water Conservation Supervisor. I notice that many of your volunteering experiences are bilingual and tailored toward assisting Spanish-speaking individuals.
